



MINUTES OF THE WHETSTONE FIRE DISTRICT BOARD MEETING, February 26th, 2019

Call to Order/Pledge of Allegiance/Roll Call/Affirmation of Quorum:

Chairperson Michelle Bell called the meeting to order. The meeting was held in the Whetstone Fire District Station 321 classroom, 2422 N Firehouse Lane, Huachuca City, Arizona.

Call to the Public:

Steve Usrey from the Whetstone Water Office board is present to speak on the old business item and would like to hold his comments until that item comes up.

Old Business:

 Review, Discussion and Possible Action of Lease or Renting options of the Whetstone Fire District Building, currently occupied by the Whetstone Water District. The building is located at 2424 N Calle Segundo, Huachuca City, AZ 85616.

Steve Usrey explains that the current board was made aware of the upcoming end to their lease for the building in question on April 17th, 2022. He is interested in finding out what options are available once the lease comes to term. He states that he received correspondence from March of 2009 giving the Whetstone Water District 180 days to vacate the premises as well as correspondence from November of 2008 from the county attorney.

At this time Chief Bidon explains that the November 2008 correspondence was between himself and the county attorney advising that the existing lease agreement with the water office was in fact an illegal lease. He goes on to state that the county attorney advised of a conflict of interest on their part due to the fact that they represent the Whetstone Fire District as well as the Whetstone Water District and both parties would need to obtain new legal counsel. Chief then states after the notice to vacate was delivered, the Whetstone Water District threatened the Fire District with a lawsuit. In order keep the district financial responsible, the Fire District board made the decision to let the current lease run to term and revisit the matter at that time.

Chief advises the board to take 60 days and have work sessions before making a definite decision on this matter. He advises that there are many options that need to be explored. Mr.

Usrey is eager to know the board's decision so that the Water District has time to make other arrangements if leasing the building is not an option and would like to be present for the work sessions. He requests a courtesy notification so that he may attend the work sessions. His information was collected by Cathy Dyer.
