Michelle Bell: Vas- 5 tons, quote did not include seer rating, over \$8,000 which is over \$2,000 greater than all the others. AZ Comfort Systems Dicon: 15 seer, 5 ton, 1 year parts warranty, lifetime warranty on all new duct work installed \$6, 849, 82. First West Service Inc: 1<sup>st</sup> page has a 5 ton, 14 seer grand air, 2<sup>nd</sup> page has a 5 ton, 16 seer grand air for \$6,680 all together, also a 5 ton ream which is a 14 seer;

5 year warranty and provides professional service instillation which includes a 1 year labor warranty. First West also offers an annual maintenance come with 2 annual inspections and 4 filter changes or 21 inspections, each inspection includes cleaning and adjusting burner assembly and cleaning ignition assembly. AZ Comfort Systems comes with a surge protector and a 3 year \$7,500 warranty for \$194 extra. Dan Coddington advised that a higher number seer is better.

Pamela Cohen: AZ Comfort Systems Dicon relies on their own essential parts and can't use any other parts.

Michelle Bell: Current assumption that the air ducts in the building are in good condition.
